St. Mark's will begin pre-enrollment for the 2017-2018 school year for all current and new K-8 students. There will not be a raise in tuition for the 2017-2018 school year. **Pre-enrollment/pre-registration fees are non-refundable.**

Why should parents pre-enroll? Any family who pre-enrolls will lock in tuition for the next year at 2015-2016 tuition rates. This will save families money and help the school plan for 2017-2018. Any family who pre-enrolls reserves their child(ren) spot in that class for next year. Provisions will be made for families with multiple students at St. Mark's.

Families may enroll the child/children at this time without paying the registration fee until August, but will not lock in tuition at the current rate. Tuition Assistance will still be handled the same way as in the past through Facts Management at <https://online.factsmgt.com/aid>.

Enrolling now also allows the school to get an idea of student numbers for each class for next year. The school can then start looking at books and other costs for the budget to be better stewards of the gifts God has given us.
